BIOGRAPHICAL NOTE:

These papers belonged to J. O. Beard and when he died, his daughter and donor, Priscilla Blosser-Rainey came by the papers. The following excerpt is from her memories of her father regarding the draft board:

"Mr. Beard did not want to serve on the draft board, but often stated someone had to do it. His friend Mr. Harpine from Broadway talked him into it. Daddy was a duty-bound person and civic minded always. Mother later said he was never the same after the War. Our cousin Mary Lee Keller wondered why he was not a fun loving cut-up like he used to be as a younger person. My sister, Mary Beard Mehegan and I remember there was always a line of cars in front of our house during the war. People came to visit him asking (begging) not to send their son. He lamented he could not do a thing outside the draft board office, but they came anyway. He was always polite as they sat in the living room talking. It was very solemn and sad time. I can remember conversations about who had two sons or who had men working on the farm and who had no one. There were some who cheated about where they lived and what they did at that time. Most farmers were very honest and hard working. Farm work was considered essential war work providing food for the military service men. Mr. Beard ran for Rockingham County Treasurer in 1951-52 'to see if someone who served on the draft board for ten years could run for public office'. The answer was no. He was not elected. He had been in the VA House of Delegates two terms 1930-34."

SCOPE AND CONTENT:

This collection contains records of the Rockingham County Selective Service Board during World War II, 1940s-1950s, specifically the activities of the "Draft Board". Included is a Governor's certificate appointing J. O. Beard to the Selective Service Board on October 10, 1940, correspondences, local board member directory and booklets.
